This quantity has been taken as 365 cubic feet-seconds, and is base upon a number of dischar e measurements taken over a period of several months. The total flow of the es Plaines River, exclusive of the drainage canal, is obtained by computing the percentage of run-off over the 75 square miles of drainage area below Lemont, adding that to the observed discharge at Lemont. The two drainage areas above Lemont and from Lemont to Jackson Street, Joliet, are 704 s uare miles and 75 square miles, respectively. (A part of the 704 square miles o drainage overflows the Willow Springs Spillway in flood time.) From analyses of run-off conditions on this stream I have estimated that the additional run-off over the 75 square miles was 20 per cent of the run-off at Lemont. The flow from the drainage canal includes not onl the water taken from Lake MiChIigaI1, but includes the entire natural and sewerage rainage of both branches of the...
