An appendix reviews current citation to legal sources under Oregon court rules, the *ALWD Guide (5th ed.)*, and the *Bluebook (20th ed.)*. Concise explanations of resources needed for researching federal law are provided throughout. Thus, *Oregon Legal Research* can be used as a stand-alone text or in conjunction with a research text concentrating on federal law. *Oregon Legal Research* was designed specifically for teaching legal research to first-year law students, but it has also been successful with upper-level classes. Moreover, practitioners, paralegals, librarians, college students, and even laypeople will find it a useful introduction to Oregon sources.
